Liability Release Form**

**By signing this legally binding hold harmless form I acknowledge the risks associated with surfing, kayaking, and snorkeling and understand that injuries may occur during participation at Menehune Surf School, LLC.** I understand that there are inherent risks involved in the sports of surfing, kayaking, and snorkeling, and that injuries are normal and ordinary occurrences, and I freely assume those risks. Surfing, kayaking, and snorkeling are dangerous sports with hazards such as rocks, reefs, ocean life, and rip currents. I fully recognize such hazards and understand the nature and existence of inherent risks. In the event of injury to my child, my dependent, or myself, I hereby release Menehune Surf School, LLC, its owners, employees, and sponsors from any and all liability claims or personal injury claims, including accidental death. Further, I release the City of San Diego, City of Del Mar, and the City of Encinitas and their officials and employees from any and all liability claims for personal injury, including accidental death, or property damage.

I agree to indemnify, defend, hold harmless, and release the City of San Diego, City of Del Mar, and the City of Encinitas, their elected and appointed officials, agents, employees, and volunteers from any and all lawsuits, damages, claims, judgments, losses, liability or expenses arising out of (1) the death or personal injury or property damage to myself, my child, or my dependant, which may be sustained while using property owned by or under the control of the City of San Diego, City of Del Mar, and the City of Encinitas, or (2) any death or injury which results or increases by any action taken to medically treat me, my child or my dependant. All of the terms above shall apply whether or not caused by the alleged negligence, whether active or passive, or any acts of omissions of the City of San Diego, City of Del Mar, and the City of Encinitas, or any of their elected or appointed officers, agents, employees, or volunteers.

In the event that I cannot be reached in a medical emergency, I hereby give permission to the physician, lifeguard, medical aide, or staff person selected by Menehune Surf School, LLC to secure proper treatment for my child, my dependant or myself. I further accept responsibility that my child, my dependant, or myself are physically able to participate in Menehune Surf, LLC activities.

I agree to allow my child, my dependant, or myself to be used perpetually and exclusively in any promotional materials, including print ads and Menehune Surf LLC websites.

I have read, understand, and approve this Release From Liability. If the participant is a minor, the undersigned parent or legal guardian warrants and represents that this Release, its significance and the assumption of risk, has been explained to and understood by my minor child or my dependant. I hereby declare, under penalty of perjury, that I am the parent or legal guardian of the named participant.
